What's NEW:

The Two-Week Freeze & HVAS

Certainly, you are all aware of the governor's two-week freeze that is now in effect in Clackamas County and surrounding counties. The freeze is in response to rapidly increasing COVID-19 numbers in various counties in Oregon. Fortunately, this freeze does not directly affect schools, as schools operate under Ready Schools Safe Learners, the sector-specific guidance provided by ODE and OHA. Transmission of COVID-19 in schools can be limited significantly through following this guidance. (The Operational Blueprint and the metrics that allow or disallow school openings are part of the RSSL quidance.)

The governor's two-week freeze includes a Travel Advisory under which self-quarantine is expected for those who travel out of state for non-essential reasons. We have a duty of care to one another to do all we can to minimize the spread of COVID-19. Thus, if a student has traveled, HVAS will encourage self-quarantine. This may be included on forthcoming Daily Health Check forms as a recommendation. It is not our intention to police this, but we do ask everyone to do their part to reduce the risk of spreading COVID-19. Please contact Mrs. Cornette if you have questions or concerns about this.

Early Dismissal TUESDAY

On Tuesday, the 24th, any in-person groups, gr.K and up, will dismiss at 12:45 PM to begin our Thanksgiving break. Preschool and PreK students will dismiss at 12:15, as usual. There will be NO afternoon childcare for Preschool/PreK on the 24th.

Gr.2-6 to Return to Distance Learning & Limited In-Person

Though Clackamas County is currently in the "transition" column for the school metrics, it is certain, based on the recent increases in daily case counts, that the county will fall into the "distance learning" category when metrics are next officially posted on Monday. Thus, AFTER Thanksgiving Break, we will return to distance learning with limited inperson instruction (LIPI) for grades 2-6. (Please see Mrs. Cornette's email for further details.) We plan to continue with this instructional model through the end of December. Your child's teacher will be in contact with you about the schedule for LIPI. Preschool, PreK, Kindergarten, and gr.1 will remain OPEN for regular childcare and learning.
